- **R v Litt** – Successfully appealed a criminal conviction (new trial ordered) where the Crown’s boot print expert changed her evidence after trial upon receipt of a defence expert report. *(Prior to joining Lenczner Slaght)*
- **Public Interest Class Action** – Co-counsel for the plaintiffs in a class action brought on behalf of immigration detainees held on lockdown in Ontario provincial correctional facilities. *(Prior to joining Lenczner Slaght)*
- **Public Interest Litigation** – Counsel to a group of families with adult autistic children seeking to challenge Ontario’s decision to cut the funding of necessary therapies. *(Prior to joining Lenczner Slaght)*
